1. Registration Application must include:

2. The cost of each 6-week session is \$120.00. Additional successive class sessions with the same dog cost \$90.00 each.

Include veterinarian proof of UP-TO-DATE vaccinations for your dog against RABIES, DISTEMPER, Adenovirus and Parvovirus (which may appear as DAP or DA2PP on your pet's shot record) and BORDATELLA.

6. Classes are held at the Atlantic County 4-H Fair Center at 3210 New Jersey Route 50, South Egg Harbor, NJ 08215. The 4H Center is easily accessible from the Black Horse Pike (Rte.322), the White Horse Pike (Rte.30), or the Atlantic City Expressway.

7. Enrollment is as a "team," as specified in this Registration Application. Change of dogs within these classes is not allowed.

8. There will be NO REFUND of class fees. If class is cancelled due to facility issues or weather, we will attempt to re-schedule that class. However, there will be no refund of class fees unless otherwise specified.

9. Class size limited to 12 Students.

10. Classes fill quickly, so register right away to ensure a spot this session.

11. You will receive a phone call or e-mail confirming the date and time of your class the Friday before that session starts.

2024 RULES & REGULATIONS

BEFORE ENTERING THE PREMISES

- A complete Registration Application must be received and approved before your dog is permitted in the training building, on training grounds, or at any function of Pinelands K-9 Club, Inc. (Collectively, "the Premises").
- All dogs entering the Premises must have UP-TO-DATE vaccinations against RABIES, DISTEMPER, ADENOVIRUS, BORDATELLA and PARVOVIRUS.
- Dogs must be checked for, and be free of INTERNAL and EXTERNAL PARASITES.
- Attack trained dogs ARE NOT allowed on the premises.

CONTROLLING YOUR DOG

- Dogs must be held on a leash at all times, except with the permission of the instructor, and only while working in advanced classes where the dogs are expected to be off lead.
- Dogs must be under control at all times while on the Premises.
- Dogs must be kept quiet while in the training building, class location (when held outside), and when entering or exiting the training building or area.
- No dog shall be left unattended at any time outside a training ring.
- If any dog displays aggression the owner may be asked to leave the class without a refund.

WORKING WITH YOUR DOG

- Please exercise and allow your dog to relieve itself before you come to class. Should your dog have an accident in the training building or elsewhere on the Premises, it is your responsibility to clean up. Your instructor will be more than happy to hold your dog for you.
- Dogs may not be worked on mats reserved for a class.
- Cutting across mats during a training session is not permitted.
- Disorderly conduct may result in dismissal from the Premises.

PEOPLE

- People arriving early for classes are asked to stand or sit quietly on the sidelines, keeping conversations to a minimum.
- Visitors are welcome to watch a class, however, they may not interfere either verbally or physically with a class.
- People under the age of 15 must be accompanied and supervised by a responsible adult.
- Trainees must keep their children quiet and under control at all times.
- Violators WILL be asked to leave.

FACILITIES

- It is your responsibility to pick up after your dog. Please report any violations of this rule to your instructor. By picking up after our dogs, we are allowed to continue to use this facility.
- Dogs are not allowed in the restrooms.
